

MEMORANDUM OF UNDERSTANDING

REGARDING USE OF RECREATIONAL FACILITIES

This Memorandum of Understanding is made on the \_\_\_\_\_ day of \_\_\_\_\_, \_\_\_\_\_, between the Commander United States Army Garrison and hereinafter referred to as "Fort Monmouth" whose address is Russel Hall, Building 286, Fort Monmouth, NJ 07703-5101, and the Board of Recreation Commissioners for Monmouth County, hereinafter referred to as "The Board" with offices at 805 Newman Springs Road, Lincroft, NJ 07738-1695.

1. Fort Monmouth is located principally in Monmouth County and is a sending district for children of the military residing at Fort Monmouth.

2. Fort Monmouth and the Board are becoming partners for the purpose of allowing The Board to use certain recreational facilities at Fort Monmouth for Board sponsored recreation programs. By permitting use of certain facilities to The Board, Fort Monmouth will increase utilization of these facilities on weekends and weekday evenings. The Board, in turn, will be able to extend the programs it offers to its residents.

3. Fort Monmouth and The Board will begin their partnership program with the use of

However, the parties intend to expand their cooperative partnering in recreation in years to come, and as a result, it is contemplated that this Memorandum of Understanding will be revised and supplemented by the addition of other programs in the form of new Schedules.

4. The Board during the term of this partnership with Fort Monmouth agrees to keep the facilities it uses in Fort Monmouth insured against loss and damage to the benefit of the United States Government with proof of insurance and policy amounts to be approved by Fort Monmouth.

5. The Board and Fort Monmouth agree that trash generated at the fields by participants in activities during the performance of this Agreement will be treated on a carry in, carry out basis. The Board and Fort Monmouth will advise their participants of this policy and will each take appropriate measures for its enforcement.

6. The Board shall at its own cost and expense provide and keep in force for the benefit of Fort Monmouth during the term of this Agreement general public liability insurance insuring the United States Government against any and all liability claims of liability arising out of the use of the Fort Monmouth facilities as described in this Agreement for injuries to any person or persons for limits of not less than \$1 million for injuries for one person in any one accident or occurrence, and for loss of damage to the property of any person or persons for not less than \$250,000.

7. The use of the same facilities by Fort Monmouth for its own events during the term of this Agreement with The Board shall not be insured by The Board.

9. This Agreement shall become effective on the date signed by the last party hereto and remain in effect for a period of five

years, with The Board having an option to extend for two additional five year periods on the same terms and conditions contained herein.
